

As of March 25, 2020 PhilHealth has paid out a total of P1.617 billion under the IRM program. Likewise, for the month of March 2020 it has paid out P6.856 billion as part of its regular benefits payment and P2.96 billion under its accelerated Return To Hospital (RTH) program.


