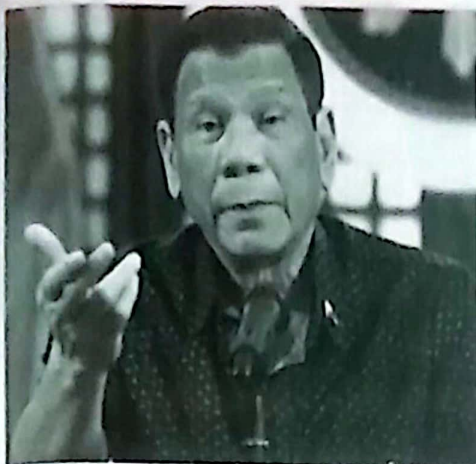

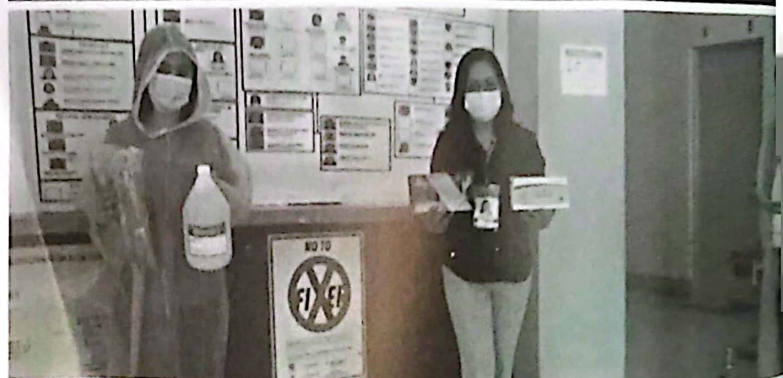

Ito ang sinasabi ng ating Constitution sa Section 18:

"Section 18. The President shall be the Commander-in-Chief of all armed forces of the Philippines and whenever it becomes necessary, he may call such armed forces to prevent or suppress lawless violence, invasion or rebellion.

"In case of invasion or rebellion, when the public safety requires it, may, for a period not exceeding sixty days, suspend the privilege of the writ of habeas corpus or place the Philippines or any part thereof under martial law.

"Within forty-eight hours from the proclamation of martial law or suspension of the privilege of the writ of habeas corpus, the President shall submit a report in person or in writing to the Congress. The Congress, voting jointly, by a vote of at least a majority of all its Members in regular or special session, may revoke such proclamation or suspension, which revocation shall not be set aside by the President.

"Upon the initiative of the President, the Congress may, in the same manner, extend such proclamation or suspension for a period to be determined by Congress, if the invasion or rebellion shall persist and public safety requires it.

PROVINCIAL ORDINANCE NO. 273-2020

AN ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION, OR OTHERWISE DISCRIMINATING AGAINST A SUSPECT, PROBABLE, OR CONFIRMED OF CORONAVIRUS DISEASE 2019 (COVID-19) VIRUS INCLUDING PRIVATE DOCTORS, NURSES, HEALTH WORKERS, EMERGENCY PERSONNEL AND VOLUNTEERS, AND SERVICE WORKERS WHO ARE ASSIGNED TO OTHER CENTERS WHERE THESE PERSONS ARE BEING TREATED, AND IMPOSING THE APPROPRIATE PENALTIES THEREIN

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides in part that every local government unit has the power to exercise all powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and essential to the promotion of the general welfare and shall ensure and support, among other things, the promotion of health and safety;

WHEREAS, President Rodrigo R. Duterte signed Proclamation 922 and Proclamation 929 which declares the Philippines under the state of public health emergency, respectively, due to COVID-19;

WHEREAS, President Duterte placed the entire Luzon island, to which the Province of Cavite is included, under enhanced community quarantine last 16 March 2020, due to COVID-19 outbreak;

WHEREAS, there is already an alarming increment of positive cases of COVID-19 throughout the Philippines wherein a total of 3,246 confirmed cases and 13 deaths as of April 10, 2020, 4:00 PM, was reported by the Department of Health;

WHEREAS, in the Province of Cavite, a total of seventy-seven (77) cases of COVID-19 patients were confirmed as of 05 April 2020, 2:00 PM;

WHEREAS, in the emanation of the COVID-19, there are various scenarios of public stigmatization towards people who have acquired the disease, whether probable, or confirmed, which likewise lead to unwanted stereotypes. Some of them are physically and/or verbally harmed and forcefully isolated by the people which causes additional anxiety to them. Some people also spread specific names of persons in social media who are alleged to be infected with COVID-19.

WHEREAS, in order to avoid further discrimination to the Caviteños, whether suspect, probable, or confirmed of COVID-19, and in order to continually ensure peace and welfare in the midst of this pandemic and quarantine, it is deemed necessary to take necessary actions and implement appropriate measures;

NOW, THEREFORE, on motion of Hon. Salazar, duly seconded by Hon. Gawaran and unanimously approved by the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

SECTION 1. SHORT TITLE. This ordinance shall be known and cited as the "Anti-COVID-19 Discrimination Ordinance in the Province of Cavite".

SECTION 2. DEFINITION OF TERMS. As used in this ordinance, the following terms shall mean:

1. Suspect, Probable, and Confirmed Persons are those defined by the protocols and guidelines of the Department of Health.

2. Health Workers – are persons who provide care and services to the sick and ailing, whether direct or indirect. They include doctors, nurses, hospital and laboratory technicians.

3. Front-liners – these persons include officers and members of the Philippine National Police, Armed Forces of the Philippines, Philippine Coast Guard, and other government rendering emergency frontline services, border control, and other critical services. They also include service workers who are working in private establishments for essential necessities and such activities related to food and medicine production which includes public markets, supermarkets, groceries, convenience stores, hospitals, pharmacies and drug stores, food preparation and delivery services, water-refilling stations, manufacturing and processing plants of basic food products and other related facilities, power, energy, telecommunications, and water supplies and other related facilities.

SECTION 3. UNLAWFUL ACTS. It shall be unlawful for any person, whether natural or juridical, to commit any act or make utterances which cause or tend to cause, disgrace, shame, humiliation, harassment, or otherwise discriminating against a person suspect, probable, or confirmed of COVID-19, health worker or front-liner under this ordinance.

If any public officer refuses or fails to give assistance to a person infected, under investigation or monitoring due to COVID-19, health worker or front-liner who is in the place of residence or domicile after obtaining clearance of the COVID-19 infection from the proper health officials, he/she shall be equally liable under this ordinance.

FILIPINO-CHINESE GROUPS DONATE P100M TO FIGHT COVID-19

The Filipino Chinese community on March 12 announced donation of P100 Million worth of medical supplies for the Department of Health (DOH) to support the COVID-19 or novel coronavirus prevention campaign of the Philippines. The 11 major Filipino Chinese business, civic and cultural organizations—led by Federation of Filipino Chinese Chambers of Commerce & Industry, Inc. The term "Filipino Chinese" or "Filipino-Chinese" is used in this statement, because it refers to geographic or cultural identity of the Philippines' ethnic Chinese and not to their citizenship. The diverse Filipino Chinese business, civic and cultural organizations represent different ethnic Chinese who are mostly Filipino citizens, but they also include sizeable numbers of those who hold passports from Hong Kong, China, Taiwan, etc., thus the broad, inclusive term "Filipino Chinese" used.

On March 11, 2020, the World Health Organization (WHO) declared Coronavirus disease 2019 (COVID-19) a pandemic. management of Emerging Infectious Diseases (IATF-ED20); the OFWs and government employees who will check-in at the community quarantine facility; and suspected and confirmed cases being transported to isolation community facilities and referral hospitals will be allowed to leave the bounds of the barangay.

Likewise, all public transportation vehicles (such as franchised taxis, PUVs, UVs, etc.) shall not be allowed even for personal purposes.

Food and other basic essentials could be

accessed thru the Molino Online Market delivery, Mercury Drug delivery system, SM Watsons, Mobile Palengke, and other rolling stores in various subdivisions within Barangay Molino III.

Strict implementation of the liquor ban, prohibition of mass gatherings, illegal gambling and illegal activities will be observed.

Meanwhile, all suspected, probable, and confirmed cases will not be allowed to undergo home quarantine/isolation but should immediately be coordinated with the City Health Office (CHO) for proper assessment and action by the Barangay Health Emergency

Response Team (BHRT). These patients will be prioritized for admission in all Level 2 and Level 3 hospitals within Barangay Molino III upon the referral of CHO and the BHRT.

On the other hand, barangay officials and residents who are most affected by the lockdown will be assisted by the CSWDO and the Emergency Response Center thru programs and inventory logistics. Barangay Molino III will also be prioritized for SAP and relief packs distribution.

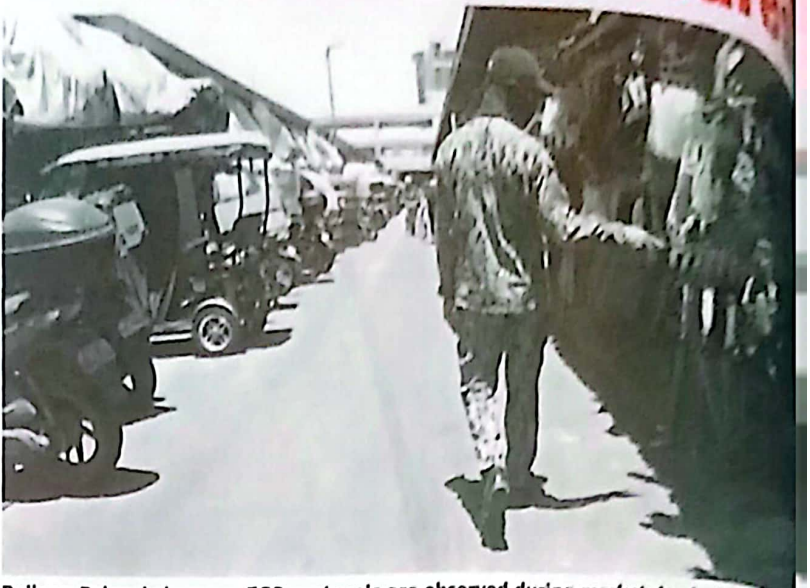

This is to raise funds for the town's COVID-19 response and to help his fellow Kawiteños, particularly the senior citizens.
