



2. Respondent is likewise of legal age, Filipino citizen, married, and with last known address at Brgy. 5. During their marriage, petitioner and respondent bore a son named Jeremy Jub A. Sandoval who was born on 13 July 2002.

Copy of the Certificate of Live Birth is hereto attached and made an integral part hereof as Annex "B";

6. Petitioner and Respondent lived harmoniously for a few years until one day, upon coming home from work Petitioner was surprised to arrive home with a visitor waiting for her;

7. As the visitor introduced herself as Rose May Sandoval, Petitioner's housemaid let her in thinking that she is a relative of Jubilee Sandoval, the Respondent on this case and Petitioner's husband;

8. Petitioner asked Rose May Sandoval how is she related to Respondent, asking who her parents are, trying to trace her husband's relation to her;

9. Petitioner was shocked to learn that Rose May Abustan Sandoval is the first wife of her husband and they have a child;

- 10. Asking for the purpose of the visitor's visit, Rose May Sandoval said she wanted to confirm whether what she heard was true - that Respondent has remarried and is currently living with his new wife:
- 11. Rose May Sandoval claimed that Respondent had abandoned her and their child and she had been looking for him and asking for his whereabouts;
- 12. After a civil conversation, Rose May Sandoval peacefully
- 13. When Respondent came home from work, Petitioner confronted him about his first marriage and admitted having married twice;
- 14. After the confrontation, Respondent then left the conjugal dwelling. Respondent left their son, Jeremy Jub, to the custody of the Petitioner:
- 15. Upon verification with the Philippine Statistics Authority, Petitioner learned that indeed, Respondent had been married with Rose May Abustan on 05 April 1989 at Quezon City.

This being the ca petitioner is entitled to the declaration of absolute nullin her marriage to the respondent pursuant to Article 35 (4) the Family Code of the Philippines.

PRAYER




