





The Department of Health (DOH) - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) is targeting to vaccinate about 1,524,327 children in the region on the upcoming nationwide "Measles-Rubella and Oral Polio Vaccine Supplemental Immunization Activity (MR OPV SIA) Phase 2 Campaign from February 1-28, 2021.

The regional office will be targeting 290,588 children in the province of Batangas, 380,067 in Cavite province, 306,619 in Laguna, 236,913 in Quezon and 310,140 in

"The regional office, our LGU partners and the vaccination teams are ready to do their tasks and reach the target children including those in far-flung communities located in the mountains," Regional Director Eduardo

DA allots P80-M for ASF test kit mass production

Lipa City, BATANGAS, Jan. 27 (PIA) - Losses in hog depopulation caused by the African Swine Fever (ASF) will soon be over once the ASF rapid test kits made by the Central Luzon State University (CLSU), in partnership with the Department of Agriculture's Bureau of Animal Industry (DA-BAI), finishes its development and distribution to commercial and backyard hog raisers.

This positive outlook on the local hog raising industry has been shared by Agriculture Secretary William Dar during the inauguration of the 1st National Meat Inspection (NMIS)-Service accredited Triple slaughterhouse held in this city last January 23.

In partnership with CLSU, the DA has allotted an P80 million fund for the mass production of 'ASFV Nanogold Biosensor' rapid test kits which can produce results within 10 to 15 minutes.

Designed to identify and differentiate ASF from hog cholera and other swine-related viruses, Dar said the test kits can be used for profiling farms for repopulation and surveillance in areas considered as the 'ground-zero' of this disease.

PH agri grows amid pandemic

"Last year, despite a perfect storm which includes the eruption of Taal Volcano, the COVID-19 pandemic, the African Swine Fever, and the series of typhoons, the country managed to attain a 19.4MMT national yield. Pinakamataas sa history ng rice production sa bansa," Dar said during a visit at the International Training Center for Pig Husbandry (ITCPH) over the weekend.



Secretary Dar noted that the import level is starting to go down as local production continues to grow with interventions and assistance for seeds, fertilizer, and capacity

building. The DA chief added that the agriculture sector posted positive growth in 2020, thanks to efforts of farmers, fishers, and other stakeholders.

Unlike several industries which were forced to close shop months-long during nationwide lockdown, the Philippine agriculture thrived during to the

COVID-19 pandemic. In fact Dar said rice production has reached 19.4-M metric tons of harvest yield, making it the 'saving grace' of the national economy.

For the next 12 months, Dar said the goal is for the industry to reach 85 percent rice sufficiency

Aid to farmers As the sector most affected by the procession of typhoons and the COVID-19 pandemic, the DA continues to roll out projects aimed to empower farmers in ensuring food security and resiliency in the country.

Part of this initiative was the swift and effective implementation of the initiatives under the 'One DA' program, which follows 12 initiatives that aim to develop the national agriculture, including farmers, fisherfolk agripreneurs.

Dar also led the distribution of P205-M worth of agricultural projects and intervention to farmer-beneficiaries in the province, which includes P75M in credit assistance from the DA-Agricultural Credit Policy Council as well as indemnity checks amounting to P1.08M for farmers who were affected by the Taal volcano eruption last year.


