
Naic tightens quarantine protocols Jue to increase in COVID-19 cases



The municipal government of Naic thru the order of Mayor Junio Dualan last February 1 tightened the implementation of quarantine protocols in the town.

This development came after the recent increase in the number of COVID-19 confirmed cases which recorded 26 new cases last January 30, 2021 after weeks of recording almost one to none positive cases

The local chief executive immediately ordered the temporary closure of the offices in the municipal hall thru the passing of the Executive Order no. 5 s. 2021 including the temporary suspension of the operation of the Business One Stop Shop (BOSS), Real Property Tax payments, Tricycle Franchise Permit as well as the voter's registration at the Local Commission on Election Office (COMELEC).

Only those in the frontlines like the Disaster Risk





Ordinance No. 5 s. 2014 authored by then authored by then Councilor Lorenz Khalil Soberano, Chair fo the Committee on Trade, Tourism, Culture, and Arts during the term of Former Mayor Herminio Lindo.

Also known as the Ternate Tourism "Ternate Ecological Fee Ordinance," it was passed to ensure the benefit and enjoyment of the people of the locality, judicious and wise utilization, protection conservation and management on a sustainable basis of its natural resources with the necessity of maintaining sound ecological balance.

Novejas explained that "to generate funds as a source of revenue to finance the

implementation of environmental and tourism plans and projects and to provide the necessary amenities and services out of the collected fee that goes to peace and order, beautification, livelihood,

health assistance."
"This is the way we can meet the needs of the local government to provide for the cleaning of garbage left by riders and tourists on the road or in Kaybiang Tunnel and to be used for the mobility of police for peace and order, rescue by MDRRMO in times of accidents within the vicinity. Saan naman kame kukuha ng funding, we are only a 4th class municipality," added

Novejas.

Kaybiang tunnel is a 300 meter long tunnel with 4.85 meter wide with 4.85 meter wide vertical clearance completed wayback July 1, 2013. The tunnel is considered the longest tunnel in the country which serves as an alternate route going to the municipality of Nasugbu. It has been frequented by local tourists, and motorcycle riders even cycling enthusiasts for souvenir photos and access to the beautiful beaches in beautiful beaches in Ternate and Nasugbu.

Meanwhile, Municipal Treasurer Brendalyn Olano pointed out the ecological fee will be collected on weekends and residents of Nasugbu are exempted upon presentation of proof of





"I am elated that after 20 years since the birth of RA 9003, the NEAP listing has now commenced This is long overdue and we need to catch up with the demand of solid waste management in our country," sabi ni Antiporda.

REQUEST FOR PROPOSALS FOR THE COMPETITIVE SELECTION OF THE JOINT VENTURE PARTNER OF THE PROVINCE OF CAVITE FOR THE DEVELOPMENT OF THE SANGLEY POINT INTERNATIONAL AIRPORT PROJECT

The Provincial Government of Cavite (PGC) of the Republic of the Philippines is again inviting qualified firms to submit Joint Venture (JV) Proposals for the development of the Sangley Point International Airport Project (the "Project").

The Project is a master-planned 1,500-hectare new international airport development to be implemented as a commercial JV arrangement between the PGC and its selected JV Partner. The PGC is the implementing agency of the Project for the Government of the Philippines. The formation and execution of the JV will be done in accordance with Provincial Ordinance No. 002-S-2012, as amended, or the PGC's Public-Private Partnership (PPP) Code and JV Ordinance.

The selected JV Partner will be responsible for co-developing the Project in joint venture with the PGC; providing the necessary equity investment, debt financing, and credit enhancements; and securing/performing Engineering, Procurement and Construction (EPC) services for the land and airport development components of the Project.

Under the terms of the Project's no objection clearance from the Department of Transportation, no sovereign loan or National Government guarantee will be granted.

The Request for Proposals (RFP), comprising: (1) the Project Feasibility Study including the Schedules and Updates; (2) the Instructions to Candidate JV Partners; and (3) the Draft Joint Venture and Development Agreement, will be available at the Office of the Provincial Governor, Cavite Provincial Capitol, Trece Martires City, Province of Cavite, for distribution to interested parties, from 1 to 30 March 2021.

To obtain a copy of the RFP, any interested party must submit a written Expression of Intent, sign the prescribed Non-Disclosure Agreement, and pay the non-refundable participation fee of PHP1,000,000 (or USD20,000). The forms of the Expression of Intent and Non-Disclosure Agreement may be downloaded from the official PGC website at https://cavite.gov.ph/home/. The deadline for the submission of JV Proposals will be on 4 May 2021.

If still interested, previously registered entities that bought the RFP during the first competitive selection process launched in October 2019 would have to submit a new Expression of Intent, update their registration details, and pay the renewal fee of PHP25,000 (or USD500).

The Province of Cavite reserves the right to accept or reject any JV Proposal, and to discontinue the second Competitive JV Partner Selection Process.

designing, developing, and prototyping robots can be done through the IDD Laboratory. She also encouraged everyone to more about robotics and technology in general.

technology in general. "Now that we have the learnings, the knowledge, the important challenge is how to share this knowledge to our students," Bagsit said.

Meanwhile, Prof. Angela Reginaldo, Director of the LSPU Extension and Training Services, echoed Ms. Bagsit's sentiments on knowledge sharing which according to her, the event caters not only to teachers but to their students as well.




