PATULOY na pinag-iingat ang publiko laban sa tinatawag na "vishing" o voice phishing scam na kadalasang tumatarget ng mga bank depositor o online bank account client para nakawin ang kanilang pinaghirapang pera.



Ang vishing ay isang modus ng scam kung saan ang scammer ay tumatawag upang makumbinsi ang kanilang nabiktima na magbigay ng sensitibong impormasyon tulad ng bank account details. Kapag nakuha na nasabing ang impormasyon, dito na maaaring nakawin ng scammer ang laman ng bank account ng biktima. Ayon sa BDO Unibank,

narito ang ilan sa kadalasang ginagamit na modus ng mga vishing scammer upang mangbiktima:

1. Tatawag sa biktima at magpapanggap na representante ng isang ahensya ng gobyerno, bangko, o di kaya'y magpapadala ng text o direct message para sila na mismo ang tawagan ng napili nilang biktima.

2. Upang makumbinsi ang biktima na sya ay lehitimo, gagamit ang scammer ng impormasyong tungkol sa credit card o bank account

ng biktima bilang dahilan ng kanyang pagtawag. Ang mga impormasyong ito ay maaaring makuha ng mga scammer sa mga dokumentong may sensitibong detalye na hindi naitapon ng maayos, o sa mga posts sa social media ng mismong biktima. May mga pagkakataon din na bumibisita o sumasali mismo ang mga scammer sa mga "credit card o bank account groups" sa social media para doon sila maghanap ng mabibiktima.

Gagamit 3. ng pananakot o mabilis at kapani-paniwalang pananalita ang mga scammer upang tuluyang makumbinsi ang kanilang biktima, tulad ng mga katagang "na-hack ang iyong account", "may na-detect na problema sa account mo", "Congrats! Nanalo ka ng...," "Special Offer! Effective only today!," o inaatasan ang biktima na i-activate ang isang offer sa ATM kapalit ng isang reward.

4. Habang tumatagal

ang usapan, tumataas din ang posibilidad na makumbinsi ng scammer ang biktima. Dahil inaakala ng biktima na lehitimo ito at hindi nya makayang putulin ang tawag o ibaba ang telepono, mas malaki rin ang posibilidad na sundin nya kung anomang instructions ang ibigay ng scammer tulad ng pagbibigay ng Card Verification Value o CVV ng credit card, username at password ng online bank account, One-Time PIN o OTP, o ang pag-click sa isang link na ipapadala ng scammer.


Sa lahat ng mga nabanggit na scenario, ang pinakakaraniwan dito ay ang pagmamadali ng scammer sa biktima nila na umaksyon na agad habang kausap ito sa telepono. Dahil dito, maaaring mataranta ang biktima at sumunod sa mga ibibigay na utos ng scammer.

Upang hindi maging biktima ng vishing scam, nagpapaalala ang BDO sa

publiko na laging maging kung mahinahon makakatanggap ng text o tawag lalo sa mga hindi rehistradong numero. Dagdag pa ng bangko na kahit na alam ng scammer ang numero, pangalan at trabaho nila, huwag kaagad maniniwala sa binibitawang mensahe o susunod sa mga instruction nito. Marapat na tapusin na ang tawag lalo na kung may pagmamadali, at tumawag sa official customer service hotline ng sinasabing ahensya o bangko, dagdag pa ng BDO.

Ayon pa sa BDO, matapos ma-verify na peke ang nasabing tawag, i-block na agad ang numerong ginamit ng scammer at i-report ang insidente sa Customer Contact Center nito.

DTI CALABARZON to hold its 1st regional arts and creative festival

In line with the Philippine Creative Industries Development Plan to develop the creative industries and elevate Filipino creativity, the Department of Trade and Industry Region 4-A, in partnership with the DTI-Competitiveness and Innovation Group and the City Government of General Trias, will embark on strengthening its region's creative industry by conducting its very first regional arts and creative festival entitled, "Fiesta Haraya 2024: Likha at Husay ng CALABARZON," on November 27 to December 1, 2024 at the Robinsons General Trias, General Trias City, Cavite.

Fiesta Harava is a portmanteau of two words representing Filipino tradition. Fiesta is a Spanish word for party or festivity. Haraya is an old Filipino word, which means imagination or vision. For the event's official tagline, "Likha" means create while "Husay" means skilled. The tagline basically signifies the services and crafts made from the expertise and brilliance of the creative people in the CALABARZON region.

The festival will showcase an array of creative goods through a trade fair, performances from artists and artisans, demonstrations and workshops from creative experts, and information campaigns from partner government agencies and private sector in the region. Through this activity, the DTI 4-A aims to help promote local arts and culture, encourage collaboration and

networking, support existing and emerging entrepreneurs from different creative clusters, and foster creative entrepreneurship, competitiveness, and innovation.

Each province in the region will have several performances each day to showcase its arts, culture, and creativity.

Some of the most anticipated activities in the festival are: a fashion featuring show handcrafted clothes, and accessories, footwear from Laguna designers and the province's fruit carving, word, and embroidery demonstration; Cavite's marching band, spoken word poetry, and painting exhibition; Batangas' calado style of embroidery demonstration, folk dance performance, and theater arts performance; Rizal's Higantes parade and bonsai workshop; and

Quezon's kiping making demonstration and dance cultural performances highlighting the Tagayan Ritual and Kiping-making demonstration. Information kiosks and services from the DTI and other partner agencies will also be available for the public such as business name registration, consumer welfare desk, business loan assistance, among others.

"We invite everyone, especially our micro, small, and medium enterprises, people from the creative industry sector, students, consumers, and creative communities, to visit our festival and celebrate with us as we build a robust creative ecosystem and develop vibrant and sustainable creative industries in our region." said DTI 4-A Regional Director Marissa C. 

to weakened immune systems. The annual flu shot is the most effective way to prevent severe illness and hospitalization among seniors, especially during typhoon season, when diseases like influenza tend to spike."

In July, the DOH announced a five-milliondose allocation of flu vaccines for seniors, to be distributed via local health centers under the **Expanded Senior Citizens** Act (Republic Act 9994). This distribution plan, set to be completed before the year ends, has been widely welcomed by senior health advocates and community leaders alike. Ignacio-Alberto Dr. expressed optimism, stating, "We thank the DOH for listening to our voices and prioritizing the protection of seniors during this high-risk period. We look forward to seeing the vaccines reach our communities soon."

Echoing these sentiments, Bayan Bakuna Lead Convenor Roderick Alapar emphasized the importance of timely flu vaccination in protecting seniors from illnesses, particularly during typhoonrelated calamities. He noted that vaccinating against the flu helps seniors avoid serious health risks, allowing them to stay protected and enjoy their golden years in better health.

In a shared commitment to seniors' health, Bacoor City Mayor Strike Revilla expressed the city's enthusiasm to participate in nationwide flu the vaccination roll-out, emphasizing the crucial role of local governments in ensuring vaccines reach those who need them the most, especially in light of the heightened health risks posed by late-year typhoons.

"Ikinagagalak namin na ilunsad ang programang ito sa Bacoor. Matagal nang hinihintay ng ating mga seniors at may comorbidities na mabakunahan sila laban sa flu. Sinisiguro namin na agad nilang matatanggap ang mga bakuna kapag dumating ito sa ating LGU. Pangunahing prayoridad natin ang kanilang kalusugan," said Mayor Revilla.

In addition to the flu vaccines, Mayor Revilla highlighted Bacoor's broader health initiatives, including the provision of free pneumococcal vaccines to seniors to further shield them from respiratory illnesses heightened by the typhoon season.

influenza-like As illnesses (ILIs) continue to rise amid unpredictable weather, health advocates encourage seniors to stay updated on vaccination schedules through barangays and local health centers. While seniors await the arrival of the advocates vaccine, recommend observing minimum public health standards, such as wearing masks and frequent hand washing, to reduce the risk of viral infections. Additionally, advocates urge the government to consider starting vaccine distribution earlier in the month in the coming year to ensure seniors receive protection well before peak flu season.


