

PROVINCIAL ORDINANCE NO. 468-2024

AN ORDINANCE INSTITUTIONALIZING THE "ANTI-ONLINE SEXUAL ABUSE AND EXPLOITATION OF CHILDREN (OSAEC) AND ANTI-CHILD SEXUAL ABUSE OR EXPLOITATION MATERIALS (CSAEM) ACT" IN THE PROVINCE OF CAVITE WITH CORRESPONDING PENALTIES AND PROVIDING FUNDS THEREOF

Introduced and Sponsored by: Hon. Romel R. Enriquez Chair, Committee on Social Services, Family, Women, Children and Elderly

Co-sponsored by: All Sangguniang Panlalawigan Members

WHEREAS, Section 3, Paragraph 2, Article XV of the 1987 Philippine Constitution, provides that the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development;

WHEREAS, Section 13, Article II of the 1987 Philippine Constitution, provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Republic Act No. 9208 or the "Anti-Trafficking in Persons Act of 2003" as amended by the Republic Act No. 10364 or the Expanded Anti-Trafficking Act of 2012, protects the child against online sexual exploitation by declaring unlawful recruitment by any means for the purpose of prostitution, pornography, sexual exploitation or maintain or hire a person to engage in prostitution or pornography;



WHEREAS, Section 11 (i) of Republic Act No. 11862, also known as the "Expanded Anti-Trafficking in Persons Act of 2022", specifically provides that LGUs shall be mandated to pass an Ordinance to combat trafficking in persons and other forms of exploitation at the local level; and develop and implement a trafficking in persons preventive education program aimed at educating and orienting the public about the crime and how it is perpetrated in current society, and the services available for victims and survivors;

WHEREAS, Republic Act No. 11930, also known as the "Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act", states that the State shall provide special protections to children from all forms of sexual violence, abuse and exploitation especially those committed with the use of information and communications technology (ICT), provide sanctions for their commission and carry out programs for the prevention, deterrence and intervention in all situations of online sexual abuse and exploitation of children in the digital and non-digital production, distribution or possession of child sexual abuse or exploitation material;

WHEREAS, Section 33 of the same Act states that local governments shall pass an Ordinance to localize efforts against OSAEC and CSAEM, take into account local culture and norms, institutionalize community-based initiatives that address OSAEC and CSAEM at the barangay level, establish OSAEC and CSAEM prevention programs that aims to educate families against OSAEC and CSAEM and provide a holistic local program for rehabilitation and reintegration under the local services welfare and development office including support and protection for victims and survivors;

WHEREAS, in the midst of the positive effect of digital advancements used for innovation, education and economic growth, it has also become an access to harm the children by making it easier for them to produce, access and share sexual abuse and exploitation materials to find like-minded offenders and reduce their risk of detection;

WHEREAS, the Provincial Government of Cavite is committed to provide safe environment and sustainable protection through stronger legislative measures that will eradicate cases of online trafficking and exploitation;

NOW, THEREFORE, on motion of Hon. Enriquez, duly seconded by Hon. Sison and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

SECTION 1. SHORT TITLE. This Ordinance shall be known as the "Anti-OSAEC and Anti-CSAEM Ordinance in the Province of Cavite";

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Province of Cavite to:

- a. The Provincial Government of Cavite recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, emotional, psychological and social well-being. Thus, it is the policy of the province to provide special protection to children in all forms of sexual violence, abuse and exploitation that are prejudicial to their development;
- b. Implement awareness programs to educate families, parents, guardians and their children in practicing positive parenting, specifically, in guiding their children on the proper and ethical use of internet or online-offline safety behaviors;
- c. Strengthen the policies to combat technology-based trafficking in persons and formulating effective response to handle and mitigate its effect;
- d. Oversee online businesses and other allied services or enterprises, such as, but not limited to, data providers, money transfers, IT equipment providers and internet installers to comply with the existing laws and its provisions in ensuring online safety transactions.

SECTION 3. COVERAGE. This ordinance shall govern all public and private institutions, departments, offices, agencies and all its instrumentalities under the Province of Cavite. It shall govern, without prejudice to existing laws for the welfare of children, their rights and undertakings relative to child's development, survival, protection and participation.

SECTION 4. DEFINITION OF TERMS. For the purpose of this Ordinance, the following terms and phrases shall mean:

- a. Child refers to a person below eighteen (18) years of age or those over but are unable to fully take care of themselves or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of physical, mental, intellectual or sensory disability or condition. For purposes of this Act, a child shall also refer to:
- 1. A person regardless of age who is presented, depicted or portrayed as a child as defined herein; and



- 2. Computer-generated, digitally or manually crafted images, or graphics of a person who is represented or who is made to appear to be a child as defined herein.
 - b. Child Sexual Abuse refers to any form of communication through any platform, format, or any physical interaction between a child and any person when the child is being used for any act or activity inducing sexual stimulation or for the purpose of sexual gratification or in pursuit of the desire to have carnal knowledge of the child, regardless of the gender of the perpetrator or the victim, or the consent of the victim;
 - c. Child Sexual Exploitation refers to any of the following acts even if consent appears to have been granted by the child:
- 1. Child sexual abuse with consideration, whether monetary or non-monetary consideration, favor, or benefit in exchange for the opportunity to perform such abusive or exploitative act;
- 2. Actual sexual intercourse with a child or children with or without consideration;
- 3. Employing fraud, machination, undue influence, intimidation, threat or deception by any person to commit sexual abuse or sexual intercourse with a child or children; or
- 4. Any other similar or analogous acts related to child abuse, cruelty, or exploitation or to be responsible for other conditions prejudicial to the development of the child.
 - d. Child Sexual Abuse or Exploitation Material (CSAEM) or Child Sexual Abuse Material (CSAM) refers to any representation, whether offline, or by, through or with the use of ICT, by means of visual, video, audio, written, or any combination thereof, by electronic, mechanical, digital, optical, magnetic or any other means, of a child engaged or involved in real or simulated sexual activities, or depicting acts of sexual abuse or exploitation of a child as a sexual object. It shall also include materials that focus on the genitalia or other private body parts of a child. For purposes of this ordinance, CSAEM may interchangeably be referred to as CSAM;
 - e. Child Prostitution refers to children exploited in prostitution and other sexual abuse, whether male or female, who for money, profit, or any other consideration, or due to the coercion or influence of any adult, syndicated or group, indulge in sexual intercourse or lascivious conduct;
 - f. Child Trafficking refers to the recruitment, transportation, transfer, harboring, adoption, or receipt of a child for the purpose of exploitation, or an adoption that is induced by any forms of consideration for exploitative purposes shall be considered as trafficking in persons;
 - g. Coin Operated Internet Machine (COIM) commonly known as "piso internet", which refers to standalone arcade system with a computer and internet connection which can be accessed through inserting any coin denomination or token, including but not limited to: PISO Wi-Fi Vendos;
 - h. Foster Care refers to the provision of planned temporary substitute parental care to a child by a foster parent;
 - i. Foster Child refers to a child placed under foster care;
 - j. Foster Family Care License refers to the document issued by the DSWD authorizing the foster parent to provide foster care;
 - k. Foster Parent refers to a person, duly licensed by the DSWD, to provide foster care;
 - I. Grooming refers to predatory conduct, act, or pattern of acts, of establishing a relationship of trust, or emotional connection by another, with a child or someone who is believed to be a child, and/or the family, guardian, and/or caregivers, whether in person or via electronic and other similar devices, for the purpose of penetrating sexual abuse or exploitation or the production of any form of CSAEM;
 - m. Information and Communications Technology (ICT) refers to the totality of electronic means to access, create, collect, store, process, receive, transmit and present and disseminate information;
 - n. Internet hotspot refers to an establishment or any place or venue that offers access to the internet. It includes hotels or motels, malls, restaurants, internet café or kiosks, public spaces or other related/similar places;
 - o. Internet Service Provider refers to a public telecommunication entity (PTE) or value-added service (VAS) provider duly

authorized by or registered with the National Telecommunications Commission (NTC) that provides users or other entities with data connection allowing access to the internet through physical transport infrastructure, and such access is necessary for internet users to access content and services on the internet, and for content providers to publish or distribute materials online;

- p. Internet Shop/Hub/Café refers to an establishment that offers or proposes to offer services to the public for the use of its computer/s or computer system for the purposes of accessing the internet, computer games or related computer services;
- q. Kinship Care is the full-time care of a child by a relative or another member of the extended family;
- r. Local Survivor Group a group of survivors in a specific region who have come together for a cause and to support one another. These groups may be affiliated with International Justice Mission (IJM), IJM partners, or others organizations alike;
- s. Network of Care refers to a Trauma-Informed Network of Government and Private Facilities and Service providers within a region, offering Programs and Services for OSAEC Survivors and their Families with a protocol that facilitates efficient and effective communication, coordination and collaboration in service delivery;
- t. Online Sexual Abuse and Exploitation of Children (OSAEC) refers to the usage of digital or analog communication and ICT as means to abuse and exploit children sexually, which includes cases in which contact child abuse or exploitation offline is combined with an online component. This can also include the production, dissemination, and possession of CSAEM or CSAM; online grooming of children for sexual purposes; sexual extortion of children; sharing image-based sexual abuse; commercial sexual exploitation of children; exploitation of children through online prostitution; and live-streaming of sexual abuse, with or without the consent of the victim: Provided, that OSAEC may be used interchangeably with online child sexual exploitation or abuse (OCSEA);
- u. Public and Private Institutions refer to establishments delivering educational, medical or social services that are owned and operated by government or public entity or privately owned organization;
- v. Sexual Abuse or Exploitation Material refers to any online or offline representation, whether visual, audio or written combination thereof, by electronic, mechanical, digital, optical, magnetic or any other means, of child engaged or involved in real or simulated explicit sexual activities.

In the online platform, sexual abuse or exploitation material shall include visual or audio or written materials or a combination thereof which is distributed via email, text message, instant messaging, chat rooms, peer-to-peer file sharing networks, social media platforms, and unencrypted and encrypted communication apps or traded on password-protected sites, bulletin boards and forums;

- w. Trauma-Informed Care is an organizational structure and treatment framework that involves understanding, recognizing, and responding to the effects of all types of trauma and seeking to employ practices that do not traumatize or re-traumatize (National Child Traumatic Stress Network, 2020);
- x. Videotaped In-Depth Interview (VIDI) shall mean a video recorded inquiry or proceeding conducted by duly trained members of a multidisciplinary team or representatives of law enforcement or child protective services for the purpose of determining whether child abuse has been committed;

SECTION 5. PROHIBITED ACTS. The following are considered acts of online sexual abuse and exploitation of children and it shall be unlawful for any person to commit any of the following acts, regardless of the consent of the child, through online or offline means or combinations of both:

- a. Online child sexual abuse material accessing, possessing, producing and/or distributing images and/or videos of child sexual abuse:
- b. Grooming of children for sexual purposes developing a relationship with a child to enable their sexual abuse and/or exploitation, either online or offline;
- c. Live-streaming sexual abuse of children using online video applications to view, and sometimes interact with the sexual abuse of children live:
- d. Sextortion coercing and blackmailing children for sexual purposes-producing and/or utilizing sexual images and/or videos depicting a child, for the purposes of sexual, financial or other personal gains;



e. Other unlawful or prohibited acts as provided for under the Republic Act No. 9775 or Anti-Child Pornography Act of 2009, Republic Act No. 11862 or the Expanded Anti-Trafficking in Persons Act of 2022 and Republic Act No. 11930 or the Anti-Online Abuse and Exploitation of Children Law.

SECTION 6. PROVISION FOR SERVICES TO VICTIMS OF CHILD SEXUAL ABUSE OR EXPLOITATION. The Office of the Provincial Social Welfare and Development Officer (OPSWDO) shall provide assistance to its component City/Municipal Social Welfare and Development Office (C/MSDO) to ensure that the child who is a victim of any form of child sexual abuse or exploitation is provided with appropriate care, custody and support for their recovery and reintegration in accordance with existing laws.

The child and his/her family shall be entitled to protection as well as to the rights and benefits of witnesses under Republic Act No. 6981, otherwise known as "The Witness Protection, Security and Benefit Act."

To ensure recovery, rehabilitation and reintegration into the mainstream of society, the concerned Local Government Units (LGUs) under the Province of Cavite and other government agencies shall make the following services available to victims of any form of child sexual abuse or exploitation:

- a. Immediate temporary emergency shelter or appropriate housing;
- b. Counselling;
- c. Free legal services, which shall include information about the victim's rights and the procedure for filing of complaints, claims for compensation and such other legal remedies available to them in a language understood by the child;
- d. Medical and/or psychological services;
- e. Livelihood and skills training;
- f. Educational assistance; and
- g. Support services to survivor empowerment, leadership development, advocacy and participation

Concerned LGUs shall continuously monitor and follow through mechanism that will track the progress of recovery, rehabilitation and reintegration of the child victims, which shall be adopted and carried out.

SECTION 7. THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) AND THE LOCAL COUNCIL ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND CHILDREN (LCAT-VAWC) in the Province of Cavite shall collaboratively work together on the following responsibilities:

- a. Monitor and keep an updated record of OSAEC cases of its component cities and municipalities;
- b. Coordinate with local agencies and non-governmental organizations to immediately respond and address the issues and problems related to OSAEC;
- c. Develop harmonized reporting and referral mechanism to ensure timely, coordinated and effective response to cases of OSAEC;
- d. Encourage and support local government units initiatives that address OSAEC;
- e. Conduct informational campaigns against OSAEC through the establishment of an Information and Education Team;
- f. Advocate services for the prevention, rescue, recovery, rehabilitation and reintegration in supporting the victims of OSAEC;
- g. Strengthen, activate and mobilize committees and organizations and specials bodies in their communities to prevent and suppress OSAEC;
- h. Recommend the utilization of funds appropriated under this ordinance for the prevention and address the proliferation of OSAEC cases in the province:
- i. Conduct technical assistance and/or capacity building;
- j. Establish international linkages and develop proper foreign coordination;

k. Exercise all the powers and perform such other functions necessary to attain the purpose and objectives of this Ordinance.

SECTION 8. ROLES, DUTIES AND RESPONSIBILITIES OF VARIOUS SECTORS.

Office of the Provincial Information Officer (OPIO). The OPIO, in coordination with the Office of the Provincial Social Welfare and Development Officer (OPSWDO), shall be in charge of the information dissemination of the Anti-OSAEC and Anti-CSAEM Ordinance in the Province of Cavite.

Provincial Council For the Protection Of Children (PCPC). The PCPC shall lead the Province, in coordination with Provincial Social Welfare and Development Officer (OPSWDO) and Office of the Provincial Information Officer (OPIO), in conducting various advocacy, campaign and awareness-raising activities on the issue of OSAEC and CSAEM to be participated in by parents, guardians, children, youth, and other community members within their barangay jurisdiction.

Department of Education (DepEd). The DepEd is encouraged to conduct various advocacies, campaigns and other forms of information dissemination activities for purposes of raising awareness among elementary and high school students on children protection against online sexual abuse and exploitation, work closely with C/MSWDO and LCPC, to conduct training for school heads, teachers and other school personnel relating to protection of children against online sexual abuse and

exploitation in handling incidents of online sexual abuse and exploitation committed to students specifically on reporting to appropriate agencies including the utilization of reporting and referral mechanisms, providing psychosocial support to victims, and maintaining the confidentiality thereof

Internet Cafè and Coin Operated Machine (COIM) Operators/ Owners. All registered internet cafès and COIM shall cooperate with the City/Municipal Social Welfare and Development Office (C/MSWDO) and City/Municipal Public Information Office (C/MPIO) in the information, education and dissemination campaign against OSAEC and CSAEM and place infographics through posters, tarpaulins, etc. containing essential

information regarding OSAEC and CSAEM which shall be posted in a conspicuous and visible area within the establishment, install and update programs and software designed to detect sexually explicit activities involving children and ensure that access to or transmittal of such materials will be blocked or filtered;

Civil Society Organizations (CSO) and Non-Government Organizations (NGO). The NGOs shall conduct rigid advocacy campaign, enhance awareness on the issue to promote child protection, assist in capacitating service providers to handle OSAEC cases and/or in the conduct of orientation on OSAEC and refer cases of OSAEC to C/MSWDO and law enforcement agencies for appropriate and child-sensitive interventions

Parents. The parents shall be responsible for the monitoring of their children against any potential threats and risks that they may encounter online, and ensure that children and young people use internet sites safely and responsibly. In addition, they are responsible for the reporting of any OSAEC case to the authorities.

SECTION 9. PROGRAMS FOR VICTIMS OF CHILD SEXUAL ABUSE OR EXPLOITATION. The Province shall extend augmentation to develop and implement the necessary programs that will prevent any form of online child sexual abuse or exploitation, as well as to protect, heal and reintegrate the child into the mainstream of society. Such programs shall include, but not limited to, the following:

- 1. Provision of services including counselling, free legal services, medical or psychological services, livelihood and skills training and educational assistance to the child pursuant to Section 8 of this Ordinance;
- 2. Sponsorship of a national research program on any form of child sexual abuse or exploitation and other acts covered by the law and the establishment of a data collection system for monitoring and evaluation purposes;
- 3. Provision of necessary technical and material support services to appropriate government agencies and non-governmental organizations (e.g Mostly financial support for training, needs of Multi-Disciplinary Team (MDTs) and network of care);
- 4. Promotion of information and education campaign;
- 5. Survivor Empowerment, Leadership Development, Advocacy and Participation; and
- 6. Establishment of a survivor network and local survivor support group.



As assessed and recommended by the local social worker, the programs mentioned above shall also be provided to immediate family members of the child victim ONLY when they are not the offending party and that there is no indication of bias in favor of the perpetrator.

SECTION 10. MULTI-DISCIPLINARY CASE MANAGEMENT. In the handling and management of cases of child victims, the approach should be multi-disciplinary, and a multi-disciplinary case conference (MDCC) shall be conducted.

- a. Multi-disciplinary Case Management brings together more than two groups of disciplines or professionals from different backgrounds and specializations and areas of expertise to organize and carry out work to address the holistic needs of the child survivor (and his/her family). It is a collaborative process of assessment, planning, implementation and review. (e.g law enforcers, social workers from the local and from the residential facility, psychologist, teachers and etc.)
- b. Multi-disciplinary Case Conference (MDCC) is a forum by which professionals having a major role in the handling of online child abuse and exploitation cases can share their professional knowledge, information or concern on the child/children. The case conference analyzes risks and recommends actions to be taken in relation to the welfare planning of the child/children and the family. All the information and discussions would be kept confidential in accordance with the Data Privacy Law.

SECTION 11. TRAININGS/CAPABILITY BUILDING. The Office of the Provincial Social Welfare and Development Officer (OPSWDO) shall provide necessary trainings and seminars or capability building to enable the members of the component cities and municipalities Local Council of the Protection of Children (LCPC) and Local Council on Anti-Trafficking – Violence Against Women and Children (LCAT-VAWC), stakeholders and other concerned community members to function efficiently. Similar trainings shall also be provided to the following officials and volunteers for the purpose of equipping them with the necessary knowledge and skills to prevent and suppress OSAEC in their area of jurisdiction or to assist in the monitoring, investigation and prosecution of cases of OSAEC:

- 1. Law enforcement officials
- 2. Social workers
- 3. Teachers and parents
- 4. Barangay-based volunteer groups such as women and child-led group and child representatives
- 5. Other stakeholders.

SECTION 12. TRAUMA-INFORMED CARE FOR FRONTLINERS. The Office of the Provincial Social Welfare and Development Officer, in partnership with medical authorities and educational institutions, a program for counselling and stress management shall be developed for social workers and other frontline OSAEC responders.

SECTION 13. ESTABLISHMENT OF A HEALTHY AND CHILD-FRIENDLY SPACE. The Provincial Government of Cavite encourages all cities and municipalities in the Province of Cavite to establish their Local Child Protection and Response Center (LCPRC) that shall serve as a refuge for child victims in general. It shall provide temporary shelter for abused children and Interview rooms.

In the absence of a LCPCR or its equivalent center, a specific room in the LGU shall be established in accordance with the requirements of a child-friendly space that shall serve the purpose of promoting the best interest of child victims.

Any assistance provided for the victim-survivor and his or her family should put paramount consideration to the "best interest and welfare of the child".

SECTION 14. VIDEO IN-DEPTH INTERVIEW (VIDI) OF THE CHILD. To facilitate the proper assessment of the survivor and further support the prosecution of OSAEC Cases, there should be established at least one (1) room specifically designed to conduct VIDI pursuant to Rule 28 and 29 of the Rules on the Examination of the Child Witness. Considering the requirements of a Child-Friendly Space, the room shall be adequately established with the proper personnel and equipment such as, but not limited to, one-way mirrors, cameras, recorders, etc.

In the absence of a LCPCR, or a fully equipped facility or room, the VIDI may be conducted in the room assessed by the social worker to be fit for child interview pursuant to the requirements of a child-friendly space, with a VIDI Mobile Kit.

There shall also be established a multi-disciplinary team (MDT) that shall conduct VIDI on the child composed of the following: social worker, properly trained police officer/investigator, psychiatrist/psychologist/licensed physician. The MDT shall be adequately

trained in conducting VIDIs to ensure that they have a child protective mindset and that evidence derived from the same will be admissible in Court.

SECTION 15. VIDI MOBILE KIT. The Office of the Provincial Social Welfare and Development Officer, thru its PCPC fund, may augment its local counter parts in cities and municipalities provided that they are compliant with the necessary facility to hold and facilitate the use of VIDI Mobile Kit, comprised of the following, but not limited to:

- 1. Video Camera with Charger and Case;
- 2. Tripod;
- 3. Laptop with Charger and Case;
- 4. Storage Media (SD Card and Flash Drives).

SECTION 16. LOCAL ANTI-OSAEC PREVENTION AND AWARENESS PROGRAMS. Aligned with Proclamation No. 417, as an annual call to action, to advocate the promotion, protection and safeguard the rights of children against OSAEC every second Tuesday of the month of February of every year is hereby declared as "Safer Internet Day for Children in the Province of Cavite" thus, its component cities and municipalities shall adopt and implement programs and activities for the said celebration and allocate necessary funds therefor.

SECTION 17. APPLICABILITY OF OTHER RELEVANT NATIONAL LAWS AND LEGAL PRINCIPLES. The provisions of R.A. No. 11862, R.A. 11930, R.A. 9775 and other relevant laws shall be applied in cases pertinent to (i) Duties of Internet Content Host, (ii) Confiscation and Forfeiture of the Proceeds, Tools and Instruments Used in Child Sexual Abuse or Exploitation, and (iii) Duties of an Information and Communication Technology Service Provider (ICTSP).

More importantly, the confidentiality of all proceedings and the privacy of the child shall be given utmost protection pursuant to existing laws, rules and regulations.

SECTION 18. PENALTIES. Without prejudice to penalties and fines as may be provided by other relevant laws, the following penalties for violations of any provisions of the Ordinance are hereby imposed as follows:

- a. First Offense: A fine of Three Thousand Pesos (Php 3,000.00) and undergo a mandatory OSAEC Seminar;
- b. Second Offense: A fine of Four Thousand Pesos (Php 4,000.00) and undergo a mandatory OSAEC Seminar; and
- c. Third Offense: A fine of Five Thousand Pesos (Php 5,000.00) and undergo a mandatory OSAEC Seminar and imprisonment.

This Ordinance shall not preclude the prosecution of a case under Republic Act No. 11930 or the Anti-OSAEC Law by the Department of Justice National Prosecution Office, which shall have control over whether to file an OSAEC Offense under this Ordinance or the Law. It should be noted, however, that Section 21 of Article III of the Philippine Constitution states that "if an act is punished by a law and an ordinance, conviction or acquittal under either shall constitute a bar to another prosecution for the same act."

SECTION 19. FUNDING. The LCPC fund shall support the advocacy programs and activities to campaign for the prevention of online child abuse and exploitation.

The operation and activities of the Council and establishment of the LCPRC shall be considered as related to gender and development projects of the province and therefore funding a part of the 5% Gender and Development Fund for every year for the capacity building and technical assistance in GAD.

The funding, however, shall not be limited to the abovementioned source or as long as other sources may be available as permitted by law.

Partnership with NGOs, CSOs, and private enterprises/individuals is encouraged for the implementation of the Ordinance.

SECTION 20. IMPLEMENTING RULES AND REGULATIONS. The Office of the Provincial Social Welfare and Development Officer (OPSWDO), in collaboration with the Office of the Provincial Governor (OPG) and Office of the Provincial Legal Officer (OPLO), shall prepare and release the Implementing Rules and Regulations of this Ordinance within six (6) months from approval of the same.

SECTION 21. REPEALING CLAUSE. The provisions of previous local ordinances, resolutions, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 22. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected there by shall continue to be in full force and effect.

SECTION 23. EFFECTIVITY. This Ordinance shall take effect upon its approval and compliance with the posting and publication requirements.


