LEE SUPPORTS SPEAKER ROMUALDEZ PLANTO INSTITUTIONALIZE P20/K RICE

AGRI Party-list Rep. Manoy Wibert Lee expressed support for House Speaker Ferdinand Martin Romualdez' push to make P20 per kilo rice sustainable.

Romualdez recently met with Department of Agriculture (DA) Secretary Francisco "Kiko" Tiu Laurel Jr. and Undersecretary Alvin John Balagbag, and committed to "personally sponsor measures to institutionalize President Ferdinand "Bongbong" Marcos' vision of affordable rice for all and stronger support for farmers."

"Buo po ang suporta natin kay House Speaker Martin Řomualdez para gawing permanente itong P20 per kilo ng bigas para sa lahat ng Pilipino. Ito rin po mismo ang isinusulong natin sa paghahain ng House Bill (HB) No. 9020 o "Cheaper Rice Act," Lee said on Tuesday during an interview with media at House Representatives.

The Bicolano lawmaker's proposed HB 9020 mandates the DA and other concerned government agencies to buy local palay with additional P5-P10 than the prevailing farmgate prices. This will ensure increase in income of local farmers while consumers will eventually enjoy lower rice

prices in the market.

Complementing the proposed "Cheaper Rice Act", Lee also pushes for more support in postharvest facilities and market linkages, and establishment of more Kadiwa centers nationwide through HB 3958 and HB 3957, respectively.

A staunch food security advocate, Lee has been consistently pushing for legislative measures that will reduce the prices of food by providing additional support for the agricultural sector and protecting the livelihood of local food producers.

Among Lee's principally authored legislations that passed into law are Republic Act (RA) No. 12022 or the "Anti-Agricultural Economic Sabotage Act", RA No. 11953 or the "New Agrarian Emancipation Act and RA No. 11985 or the "Philippine Salt Industry Development Act".

Lee also urged DA to streamline requirements to facilitate the distribution of farm equipment and services that will help farmers and fisherfolk increase their production and income.

nutrition scholars. The LGU will shoulder the SSS contributions of 495 barangay health workers and 26 nutrition scholars for one year worth P4.75 million.

"SSS commends the government's commitment in protecting its frontline workers through social security membership. We hope that this partnership will serve as a model for other local government units to follow and we look forward to replicating this success in other areas," Montalbo said.

Victorias City Mayor Javier Miguel Benitez said this is more than just a program but commitment to social security protection. "It's a promise of providing the long-term security you deserve for the selfless work you do for the Victoriasanon families," Benitez said.




