mitigation and agricultural productivity.

The RDC-X RPMC monitoring team WAS composed of evaluators from the Presidential Management Staff (PMS), the Department of the Interior and Local Government (DILG) Region X, the Department of Economy, Planning, and Development (DEPDev) Region X, and Engr. Modesto C. Babaylan, private sector member of committee. monitoring team from the Provincial Government of Camiguin also participated in the activity.

In Mambajao, the Municipal Disaster Risk Reduction and Management chief officer, Ms. Raquel B. Ranara gave a report on the Early Warning System (EWS) installed in their municipality. She noted that the automated alerts and real-time warnings have improved the response times during weather disturbances, contributing to the protection of lives and property. She also recognized the development Contingency Plan for the Hibok-Hibok volcanic eruption as a critical step in bolstering local readiness coordination.

Catarman Mayor, Hon. Kiterio Antonio U. Palarca II, expressed his sincere appreciation for the technical assistance provided by DOST. He highlighted several initiatives, such as the provision of cacao production equipment to the Catarman Cacao Growers Association, the installation of a Cold Storage facility for fishery products, distribution of PORTASOL units to local farmers. Mr. Edgardo Caulin, a beneficiary, praised PORTASOL for reducing the drying time of cacao beans and offering a cleaner, more efficient alternative to traditional street-side drying methods. This has contributed to the production of higherquality cacao products, especially tablea.

Another inspiring story in Sagay was told by Engr. Alex Dagaraga. He emphasized the value of having a reliable power source at the evacuation center, especially during emergencies. The solarpowered system ensures continuous lighting and supports basic energy needs, creating a safer and more comfortable environment for displaced families. He noted that this facility has significantly strengthened municipality's overall disaster response capabilities.

The results of the monitoring team's assessment resulted in the recommendation to adopt the EWS in all municipalities to enhance disaster risk reduction and management efforts. The PORTASOL units, in particular, were acknowledged promoting food safety and improving post-harvest handling within the agrifishery sector.

The monitoring team lauded the successful implementation of DOSTassisted projects in Camiguin and emphasized the importance of replicating these best practices in other areas. It also highlighted the importance of sustained collaboration among stakeholders, recognizing the strong partnership among DOST, Local Government Units, and community beneficiaries as a key factor in the success of the project The RPMC-X field

monitoring in Camiguin exemplified transformative impact of science, technology, and innovation in local development. It also demonstrated the power of coordinated, multisectoral efforts in delivering solutions that are both sustainable and responsive to the evolving needs of communities. (Nice Nerjay C. LEE WELCOMES EXPANDED PHILHEALTH COVERAGE FOR KIDNEY TRANSPLANT, PUSHES FOR ADDT'L BENEFITS

AGRI Party-list Rep. Manoy Wilbert Lee lauded the new benefits of the Philippine Health Insurance Corporation (PhilHealth) for kidney transplant patients, as he renewed his call for more free medical services for Filipinos by the state health insurer.

sa PhilHealth sa pakikinig sa matagal na nating panawagan na palawakin ang mga benepisyong pangkalusugan para sa ating mga kababayan na karapatan at deserve nilang matanggap, na layunin ng ipinaglalaban nating tunay na Universal Healthcare," Lee said. According to Lee, given

the resources currently available to the PhilHealth, it should be able to fully cover not just the dialysis and kidney transplant, but other chronic diseases and critical services as well.

stressed.

PhilHealth recently launched the new benefits for adult and pediatric patients with stage 5 chronic kidney disease (CKD) who have ùndergone kidney transplant. President Ferdinand "Bongbong" Marcos Jr. also visited the National Kidney and Transplant Institute (NKTI) to personally witness the launch of the new benefit scheme.

PhilHealth previously implemented increases in hemodialysis sessions from 90 to 156 per year, from P2,600 to P6,350 per session, and coverage for kidney transplantation from P600,000 to P2.1 million.

It can be recalled that Lee was the first to expose that PhilHealth had billions of available funds in September 2023. From filing House Bills and Resolutions, conducting consultations,

propounding interpellation questions during budget deliberations, he persistently urged the state health insurer to use these "unused funds" to expand its benefit Lee's packages. aggressive efforts led to the implementation of

PhilHealth's increased benefits and free medical services.

"With PhilHealth's existing funds, they can very well afford to implement additional increase in all benefit packages. Dapat lang damihan at bilisan pa ang implementasyon nito dahil araw-araw, marami

The court determined in 2005. Delilan's reporting on a dispute cited official complaints without additional commentary or malicious by the constitutional

intent. This action was deemed to be within the realm of responsible journalism and protected freedom of the press.

"This ruling underscores fundamental tenet of press freedom: journalists should not be penalized for reporting matters of public interest in good faith and without

actual malice," said Undersecretary Jose Torres Jr., executive director of PTFOMS. "The law clearly demands a higher standard of proof in libel cases involving public figures."

"Mr. Delilan's acquittal is a personal victory and a reaffirmation of the vital role the press plays in a democratic society," said Torres. "We commend the court's decision and reiterate our strong commitment safeguarding journalists harassment, from intimidation, and prolonged legal battles meant to stifle critical reporting.

PTFOMS is committed to institutionalizing reforms to prevent the misuse of libel laws against the media and stands ready to support media practitioners in their pursuit of safe, ethical, and fearless iournalism.

Earlier this week, PTFOMS praised the establishment by the Philippine Press Institute of Media-Citizen Councils "platforms for dialogue, oversight, and mutual understanding."

The Media-Citizen Council is a multisectoral, communitybased, and independent group that aims to resolve conflicts between and among media and those who complain about inaccuracies in news reports via mediation through Appropriate Dispute Resolution.

It works on the framework of the Philippine Initiative under the Philippine Plan of Action for the Safety of Journalists and on the framework of independent media self/co-regulation, media accountability and safety, ethical and responsible journalism, good journalism as a public good, and strategic engagements with various sectors in the community, including the local government units, government agencies, and law enforcers.



Held concurrently with its national elections and the mid-year general assembly, bearing the theme 'Fighting Fake News as a United Mission,' National Press Club President Leoniel Abasola, Dr. Lily Lim, and the Presidential Task Force on Media Security (PTFOMS) Undersecretary, Joe Torres Jr. extended their message of support towards the organization, expressing their immense gratitude to PAPI for their enduring partnership over the years.

In his speech, Torres ensured that the status of late-Chairman the Emeritus of PAPI, Juan "Johnny" P. Dayang Sr., is taken into careful investigation to obtain justice in its right order. Dayang was shot and killed in the evening of April 29 by now-identified gunmen at his house in Kalibo, Aklan, where he served as its former officer-in-charge mayor after the 1986 Philippine Revolution.

Additionally, veteran broadcast journalist and re-appointed Secretary of the Presidential Communication Office (PCO), Jay Ruiz, showed his full support to the outgoing President, Nelson Santos, and PAPI by attending the event and delivered a speech that empowered wise and critical decisions among the publishers in the age of digital media and the need to forge collaborative effort in fighting relentlessly with fake news, hence imposing penalties to fake news peddlers.

"Kailangan tayo magkaisa, labanan natin itong fake news, at iimpose na dapat sila rin magbayad ng buwis, magkaroon [ng] kahit na papaano regulasyon o pananagutan kung yung plataporma mo ay nagagamit sa fake news," Ruiz mentioned.

"Maganda po yung relationship ng PAPI at ng PCO, at 'yan po ay magpapatuloy habang nandito po kami. Tiyak po 'yan. Kasi nais naming ipaabot sa mamamayang Pilipino – hindi lang dito sa Metro Manila, kundi sa buong Pilipinas na ang gobyernong Marcos ay para sa tao. Magtulungan po tayong ipa-abot ang

programa, aktibidades, at mga polisiya ng gobyerno," he added.

Hence, alongside the assembly and elections, PAPI then paid tribute to the 90th birthday of Dayang where his son, Consul General to Turkey Juan "Jed" Dayang Jr., expressed his heartfelt thanks to the organization through a video message emphasizing that remembering is not enough – if his father were truly honored, shall the memories, contributions, and the legacy left by his father, not only with the organization, but also all over the country that had helped flourish the press freedom, must be carried forward.

"He believed that journalism was never about comfort, it is about courage. So I ask of you now, let's not reduce his death to a headline, let's not treat this tribute as a farewell – let it be a signal, challenge, commitment to speak when it is dangerous, to write when it is unpopular, to never trade truth for access, or silence for safety," Dayang said.

In high hopes for the new board members, Jed Dayang also mentioned in his video to continue fighting for press freedom, and moving forward, as their family will always be there to support the organization, just like what his father used to do.

The newly elected officials are set to take office after their oathtaking, which is yet to be announced by the new board, and will serve until (Binsoy 2028.

Ruiz also highlighted the administration's three major communication and public engagement programs under President Ferdinand "Bongbong" Marcos Jr. The first is the Bagong Pilipinas Presidential Action Center, a one-stop hub meant to directly connect citizens with government services. The second, emphasized, is the national fight against fake news. The third is People-Centered Communication - an initiative designed to bring government closer to the people by ensuring they are well-informed of their rights and the services available to them.

"Let the people know what benefits they can from government," Ruiz stressed, reinforcing the principle that communication is not just about information dissemination, but also about empowerment and inclusive governance. His words served as a reminder that the media and government must work together to ensure that citizens are not only informed but also protected from

manipulation.

The event also highlighted the strengthening partnership between PAPI and the PCO. Both institutions affirmed their commitment developing information channels that resonate with the needs and concerns of the public. Through collaboration, they aim to amplify voices of truth and provide platforms that support honest reporting and civic education.

In closing, Secretary Ruiz's message resonated deeply with the PAPI members present. The shared vision of a "Bagong Pilipinas" rests on the shoulders of a well-informed citizenry one that is equipped not only with facts but with the power to discern and engage. As Ruiz aptly put it, "In a Bagong Pilipinas, a well-informed citizen is an empowered citizen."


