Strengthening Power Knowledge: NGCP Hosts Power 101 Session for PIA and South Luzon Media

Tagaytay City, Cavite – July 17, 2025 — Against the scenic backdrop of Twin Lakes Hotel in Tagaytay City, the National Grid Corporation of the Philippines (NGCP) brought together regional offices of the Philippine Information Agency (PIA) and members of the local media for its Power 101 Session—a day dedicated to demystifying the operations of the country's power grid.

the session provided a rare opportunity to go behind the scenes of the transmission system that fuels much of the country's daily life. Beyond just press releases and power alerts, we were given a clearer look at how NGCP operates in real time, ensures grid reliability, and responds to crises and emergencies in a constantly evolving energy landscape.

The event opened with key insights from NGCP's South Luzon operations and public affairs leaders:

Engr. Redentor Gerardo Jumarang, ACC Power Dispatch Section Supervisor of the Luzon System Operations (LSO), explained how real-time data is monitored to maintain grid stability and load balance.

Engr. Patricius Paulus P. Baldonasa, Construction Projects Regional Senior Manager οf Infrastructure **Construction Department** (ICD), discussed the ongoing infrastructure

As a media participant, projects that aim to expand and modernize the grid across South Luzon.

Engr. Dante Castro, District Senior Manager for South Luzon Operations, emphasized importance of localized solutions and regional readiness when addressing grid-related challenges.

Atty. Cynthia P. Alabanza, NGCP Spokesperson and Head of the Public Relations Department, led a session on crisis communication, underlining the role of media in ensuring accurate and timely reporting during power incidents.

The Power 101 session wasn't just technical—it was deeply collaborative. Through open discussions and Q&A exchanges, media practitioners and government communicators were able to ask tough questions and explore complex topics such as renewable energy integration, forecasting, and disaster






