

"The SK was meant to be the youth's platform in governance, but it seems to be losing its identity," Remulla said. Йe emphasized the need to reassess whether the SK still serves its intended function or if reforms—or abolition—are necessary to better

represent the youth.

The proposal sparked mixed reactions from lawmakers and youth advocates. Some agreed Remulla's observations, arguing that the SK has become ineffective and overly Others, politicized. however, defended the

institution, saying that the problem lies not in the concept but in the lack of proper training, resources, and support for young leaders.

Remulla clarified that the DILG is open to consultations and further discussions on the matter. also suggested exploring alternative mechanisms to ensure that the youth continue to have a meaningful role in governance, even if the SK is eventually dissolved.

As the debate continues, the future of the Sangguniang Kabataan hangs in the balance. Whether through reform or replacement, the goal remains clear: to ensure that the voices of young Filipinos are heard and valued in shaping the nation's future.

A fleet of ten electric tricycles now operates daily after class dismissal, ferrying students from the school gate to Mahogany Avenue and Mendez Crossing exits.

These locations serve as key transfer points where students can access other public transport options.

The program was designed in response to growing concerns over student safety, especially during rainy days and peak traffic hours.

"This is a band-aid solution," Mayor Tolentino admitted during an interview.

"The best fix would be constructing proper

sidewalks downhill so students have a safe path to walk. That's our next step."

His remarks reflect a broader vision for infrastructure improvements that prioritize pedestrian safety in school zones.

The mayor also expressed optimism about expanding the shuttle service to other schools in Tagaytay, contingent on the success of the pilot phase.

The city government is closely monitoring the program's impact and reception among students and parents.

School Principal Perlita Viİlanueva

emphasized that the shuttle service is entirely voluntary. "Hindi ito required," she said. "Kung sino lang ang may gustong sumakay.

Kung gusto nilang mag-walk or may service 'yung iba, depende sa bata." This flexible approach ensures students retain autonomy over their daily commute.

The launch has been met with appreciation from the community, with many praising the city's proactive stance on student welfare.

As the pilot continues, stakeholders remain hopeful that this initiative will pave the way for more inclusive and safety-oriented transport solutions across the city.


