

Remulla Appointed as New Ombudsman by President Marcos

MANILA, Philippines — President Ferdinand "Bongbong" Marcos Jr. has appointed Justice Secretary Jesus Crispin "Boying" Remulla as the new Ombudsman of the Republic of the Philippines, a move that signals a strategic shift in the administration's approach to government accountability and legal oversight.

The appointment, confirmed on Tuesday, October 7, places Remulla at the helm of the constitutionally independent Office of the Ombudsman, which is tasked with investigating and prosecuting public officials accused of corruption, misconduct, and abuse of power. His transition from the Department of Justice marks a critical moment in the Marcos administration's efforts to reinforce institutional integrity.

Remulla, who has served as Justice Secretary since 2022, is widely recognized for his leadership in legal reform, human rights advocacy, and modernization of the justice system. Under his watch, the DOJ launched initiatives on drug policy transformation and digital case management, earning praise from both domestic and international observers.
