Greenhouse with Hydroponics Turned Over to Brgy. Calumpang Cerca Farmers

In a significant step toward modernizing local agriculture, a greenhouse equipped with hydroponic technology was officially turned over to Barangay Calumpang Cerca, Indang, Cavite on October 17, 2025. Elaiza Nicole Dotimas of the Bureau of Plant Industry (BPI), with support from Regional Director Fidel Libao of the Department of Agriculture (DA) Region IV-A.

The event was hosted by Punong Barangay Vergel C. Fidel and witnessed by key local leaders including Mayor Virgilio "Vergel" Fidel, Vice Mayor Ferdinand "Ferdie" Papa, members of the Sangguniang Bayan, Municipal Agriculturist Wilmer Cabrera, and presidents of various **Farmers** Indang Organizations. Residents of Calumpang Cerca also gathered to celebrate the milestone.

The newly established greenhouse is more than just a facility—it represents

a gateway to innovation for local farmers. Through hydroponics, farmers can grow crops without soil, using nutrient-rich water solutions that promise higher yields and better quality produce. This method is especially beneficial in areas with limited arable land or unpredictable weather conditions.

Officials emphasized that the greenhouse will serve as a learning hub for sustainable farming practices. Training programs and hands-on demonstrations will be


