RA 12312 Signed Into Law: Congressman Ony Ferrer Champions Anti-POGO Act of 2025

In a decisive move to protect national security and public welfare, President Ferdinand R. Marcos Jr. signed into law Republic Act No. 12312, also known as the Anti-POGO Act of 2025. The legislation marks a significant shift in the Philippines' stance on offshore gaming operations, officially banning Philippine Offshore Gaming Operators (POGOs) and all related activities.

Congressman Ony Ferrer, Chairman of the House Committee on Games and Amusement, played a central role in crafting and advocating for the measure. As

one of the principal authors of House Bill No. 10987, Ferrer worked closely with fellow and stakeholders to ensure the bill's passage through both chambers of Congress. The Senate counterpart, Bill No. 2868, was consolidated into the final version of RA 12312.

The law repeals Republic Act No. 11590, previously which regulated and taxed POGO operations. Under RA 12312, all forms of offshore gaming including betting, content provision, and support services—are prohibited. The move comes amid growing concerns over criminal activities linked to POGOs, including human trafficking, cybercrime, and money laundering.

Congressman Ferrer expressed pride and gratitude for being part of the legislative team that pushed the bill forward. "Isang karangalan po bilang Chairman ng House Committee on Games and Amusement na maging bahagi ng panukalang ito," Ferrer said, thanking both government agencies and controversies surrounding Trias, Cavite. private sector partners for POGO-related crimes. their support in passing the law.

The Anti-POGO Act is seen as a proactive measure to restore peace and order in communities affected by offshore gaming hubs. It also aims reinforce the Philippines' commitment to upholding public safety and moral integrity, especially in light of recent

With RA 12312 now in effect, enforcement agencies are expected to begin the shutdown of existing POGO operations and prevent future offshore gaming activities. 
