**ORDER**

Before this Court is a Petition for Accreditation of **CAVITE TIMES JOURNAL** filed by its Publisher and sole proprietor Francia A. Orlain, praying that said newspaper be accredited and declared qualified to join the raffle and publication of legal and judicial notices and other similar notices in the area under the jurisdiction of the Regional Trial Court, City of Dasmariñas, Cavite.

Considering that the herein petitioner has complied with all the requirements set forth in Supreme Court Administrative Matter No. 01-07 dated October 16, 2001, RE: Guidelines in the accreditation of Newspaper and Periodicals seeking to Publish Judicial and Legal Notices and the provisions of P.D. No. 1079, the Petition is hereby **GRANTED**.
