Imus City Veterinarian Dr. Ma Belle Depayso said that while ASF cannot be transmitted to humans the entry of the virus could wipe out hog populations negatively impact the economy of Imus City.

Depayso added that virus is highly contagious. "Kapag naapektuhan ang mga baboy ng ASF, the mortality rate is very high kaya

dapat tayong maging mapagbantay," said Depayso. Maliksi said that it is safe to eat pork.

"'Wag po tayong matakot kumain ng karneng baboy as long at it came from legitimate slaughterhouse at dumaan sa masusing inspection and mga baboy bago katayin at ibenta sa mga palengke. Para makasiguro, just demand for the Meat Inspection Certificate issued by the

NMIS," Maliksi said. Cavite Governor JonVic Remulla had already issued a ban on live hog import from provinces in Luzon where there were confirmed cases of ASF.
